

6 Category One Aboriginal Reserves (without maps) Lands Which Were At One Time Reserved For The Purpose Of Aboriginal Occupation And Use

Note: Location given only by town lot number in reserve number order.

RESERVE NUMBER: 747

LOCATION: Beagle Bay, near the Fraser River, on the western side of King Sound (600,000 acres).

No files located.

CREATED: 13 November 1884

CANCELLED: 18 June 1891

Established with the intention of allowing Aborigines to pursue their traditional lifestyle. It was replaced by Reserve 1834.

RESERVE NUMBER: 941

PURPOSE: "Aboriginals."

LOCATION: Avon District (500 acres).

No files located.

CREATED: Possibly 1883

CANCELLED: 6 August 1976

No information is available on this reserve other than that on the Crown Reserves register. Its existence has not been definitely recorded in any other source found to date. As a starting point for further research – given the obvious connection with Reserve 940 – a comment from Peter Biskup's *Not Slaves, Not Citizens*, p.48, notes the Church of England had two children's institutions in the 1880s. The first was near Busselton (Reserve 940). The second was transferred from Perth to the Swan in the 1880s. Other sources show this to be the Swan Native and Half-Caste Home. This institution may have been temporarily allocated Reserve 941 though it may have eventually held a freehold title.

In 1896, the magistrate wrote that the land was not being used, a statement which probably failed to take into account earlier comments that Moraitch was often away as he needed to earn money to develop his own farm. The farm was taken from Moraitch and the land given to recently arrived white settlers. A map of this reserve could not be located.

Allocated to Johnny Penny to farm at his request. Like Moraitch, Penny received strong support from the Katanning Resident Magistrate but this support was also later withdrawn. In 1896, the magistrate wrote that the land was not being used, a statement which probably failed to take into account earlier comments that Penny was often away as he needed to earn money to develop his own farm. The farm was taken from Penny and the land given to recently arrived white settlers. A map of this reserve could not be located.

In the same manner as Moraitch and Penny, Farmer lost his land which was given over to recently arrived white settlers. A map of this reserve could not be located.

Created as a camping site, the reserve came to serve the nearby mission. Conditions at the site in the 1930s were difficult and caused great hardship, particularly the severe shortage of water and poor sanitation. As a result of these conditions, a number of infants died from diseases. It was claimed parents were told by a missionary not to bring their children to the mission hospital "as they died in any case and they might just as well die on the reserve." In 1972, control of the reserve was transferred to the Department for Community Welfare.

Intended to replace reserve 21096, this site had a good water supply and was close to trucking yards. It was cancelled for two reasons. First, pastoralists claimed that the site hindered their industry. Second, DNA could not get people to camp on the site. Reserve 22585 was replaced by Reserve 23985.

The Department of Native Affairs bought the lots from the Moora Roads Board after both agreed that Aborigines visiting the town and staying overnight needed a place to camp. The DOLA file refers to water and sanitation problems and also suggests the reserve was not much used. In 1955, the Roads Board requested the land to build houses for Aborigines. The Lands Department declared the reserve was not suitable for the purpose. The Roads Board were allowed to purchase the land with the proviso they did not use it for Aboriginal housing.

In 1950, DNA requested a site in Broome to house an employee. In 1961, the Department requested the purpose be changed to "Native Housing," with the aim of using the site to provide housing for Aboriginal aged pensioners. The change in purpose was effected on 9 February 1962. The file does not indicate what development took place but control of the site was transferred to the DCW in 1972. The reasons for the cancellation of the reserve are not known.

The file does not indicate what happened to this reserve and the Crown Reserves register does not show it as having been cancelled or having its purpose changed. A map of this reserve could not be located.

Created because the Department of Native Affairs believed there was "an urgent need" for a camping ground for Aborigines at Wagin. The AAD file contains a list of residents from 1962. Basic accommodation was built on the

reserve but this had been demolished by 1970 and the former residents were moved to town housing. In 1972 control was transferred to DCW. The shire then requested the site for recreational purposes and, as there was no objection from DCW, on 31 January 1975 the purpose was changed to "Recreation." A map of this reserve could not be located.

However, there is no indication on file as to whether any houses were built. If any were, they were gone or uninhabitable by 1980. In 1981, DCW declared that the land was no longer required.
